ELECTION OF OFFICERS

AFFIDAVIT

1. Section 22 of the Constitution and By-laws of UA Local Union 393, provides as follows: No member shall be eligible to be nominated for office in the Local Union unless he/she is a Journeyperson member and has been a member of the United Association and the Local Union in good standing for at least a period of two (2) years immediately prior to the election. Any Journeyperson member, who owes or has paid a reinstatement within a period of two (2) years immediately prior to the date of election, shall not be eligible to be nominated for office in the Local Union.

2. Section 23 of the Constitution and By-laws of UA Local Union 393, provides as follows: Only qualified Journeyperson members of the Building and Construction Trades, Metal Trades or Divisional Branch of the Local Union shall be eligible for the following offices in a combination Local Union, 1. President, 2. Vice-President, 3. Business Manager-Financial Secretary/Treasurer, 4. Business Agents, 5. Members of Examining Board, 6. Majority membership on Local Union's Executive Board. Journeyperson members of the Metal Trades Branch of the Local Union shall be eligible for all other offices.

No member shall hold more than one of the following offices during any one term of office: Business Agent, President, Vice-President, Recording Secretary, members of the Finance Committee, members of the Executive Board, with one exception, the Business Manager shall also hold the office of Financial Secretary-Treasurer.

3. Section 504 of the Labor-Management Reporting and Disclosure Act of 1959, as amended, provides in part as follows: "(a) No person who has been convicted of, or served any part of a prison term resulting from his conviction of, robbery, bribery, extortion, embezzlement, grand larceny, burglary, arson, violation of narcotics laws, murder, rape, assault with intent to kill, assault which inflicts grievous bodily injury, or a violation of title II or III of this Act, any felony involving abuse or misuse of such person's position or employment in a labor organization or employee benefit plan to seek or obtain an illegal gain at the expense of the members of the labor organization or the beneficiaries of the employee benefit plan, or conspiracy to commit any such crimes or attempt to commit any such crimes, or a crime in which any of the foregoing crimes is an element, shall serve or be permitted to serve...

(2) as an officer, director, trustee, member of any executive board or similar governing body, business agent, manager, organizer, employee, or representative in any capacity of any labor organization,...during or for the period of thirteen years after such conviction or after the end of such imprisonment, whichever is later, unless the sentencing court on the motion of the person convicted sets a lesser period of at least three years after such conviction or after the end of such imprisonment, whichever is later, or unless prior to the end of such period, in the case of a person so convicted or imprisoned, (A) his citizenship rights, having been revoked as a result of such conviction, have been fully restored, or (B) if the offense is a Federal offense, the sentencing judge or, if the offense is a State or local offense, the United States district court for the district in which the offense was committed...determines that such person's service...would not be contrary to the purposes of this Act...

(c) For the purpose of this section –

(1) A person shall be deemed to have been ‘convicted’ and under the disability of ‘conviction’ from the date of the judgment of the trial court, regardless of whether that judgment remains under appeal.

(2) A period of parole shall not be considered as part of a period of imprisonment.”
